

# **AUGUSTA CHRISTIAN SCHOOLS 2023-2024 AFTER SCHOOL ACTIVITIES PROG**

## **PURPOSE**

The **After School Activities Program's (ASAP)** purpose is to provide a safe, structured environment for children of Augusta Christian School working parents, who are unable to pick up their student(s) immediately following school dismissal. Professionally trained Christian adults will supervise students in a safe and loving environment. A homework time, game time, refreshments, and access to the playground equipment will be provided.

**This is not intended to be a “drop-in” program.** We must be able to provide a sufficient number of trained workers to properly supervise our children.

Therefore, we ask that you access your need of this program and select either option 1 or 2. Option 3 is reserved for emergency situations, when parents are unable to pick up their child due to an unforeseen circumstance.

## **TIMES**

The **After School Activities Program** will be open to school families (K4-5<sup>th</sup> grade) on all full school days. On full school days, students who have registered for ASAP will be supervised from dismissal time (K4-3<sup>rd</sup> grade) (2:30) and (4<sup>th</sup>-5<sup>th</sup> grade) (2:45) until 6:00pm.

**Preschool children will be bused from the Fury's Ferry campus to the Baston Road campus.**

\*School personnel will supervise any student not picked up by their parents until 3:00pm. After 3:05pm, any students not picked up will be taken to ASAP, and parents will be charged \$15.00 if picked up before 4:00pm or \$20.00 after 4:00pm.

## **FEES**

### **Option 1**

Full-time (5 days per week – dismissal until 6:00pm) \$100.00 per week

### **Option 2**

Part-time (5 days per week – 1 hour/day dismissal until 4:00pm) \$75.00 per week

If absent more than two days, a prorated rate will be charged for that day of the week.

### **Option 3**

Hourly rate (rate per hour or any part of an hour) \$17.00 per hour

**Late Fee**

Parents will be charged a \$3.50 per minute per child after 6:00pm.

Accounts should be paid weekly. **If an account remains in arrears past two (2) weeks, your child will not be able to attend ASAP until the balance is paid in full.** A parent must sign in all students each day.
